#### ii. Projects For 2011-2012

Chris and Stacy outlined some of the major projects ahead for the school. Much of this will inform the discussion at the GC strategic retreat in August.

# iii. Budget Review for FY 2010-2011

The latest Multi-Year Projection budget was briefly reviewed in anticipation of this coming Wednesday's meeting, where a more in-depth budget discussion will take place.

Most recent numbers for 2010-2011 were discussed, showing:

- o Revenue Limit revenue of \$1,489,752
- o Total revenues of \$2,586,238
- Special Education Encroachment of \$403,640
- Total expenditures of \$2,581,748
- Net increase in fund balance of \$4,490
- Ending balance projected as \$366,734 (14% of budget)
- Reported financial numbers are **not** from Audited Report

### **c.** Looking Ahead 2012 and Beyond (Open Board Discussion)

Discussion focused on collecting agenda items for in-depth discussion at the August retreat. Items suggested include:

- exploration of the boundaries between strategic and operational issues, and what should be the GC's primary responsibilities
- Policy development around contracting and contracting-authority delegation
- Staffing and configuration for middle school as enrollment peaks at 324
- Plans for replicating the CLC model elsewhere
- Fundraising and fundraising relationships
- Retreat location (find a site conducive to a productive retreat)
- d. Community and CLC Board: Open Forum Q&A Opportunity

Some questions about how to understand the present-year budget assumptions, given that the State has not finalized a budget.
